Chairman Gibson called the regular session meeting of the Board of Trustees of the University of Arkansas to order at 1:37 p.m. on Tuesday, November 15, 2022, in the Green Room of the John F. Gibson University Center, at the University of Arkansas at Monticello, via in person and virtually.

1. Approval of Minutes of the Regular Meeting Held September 8-9, 2022, and Special Meetings Held September 13, 15, 17, 20, 30 and October 14, 2022:

Upon motion by Trustee Dickey and second by Trustee Eichler, the minutes of the regular meeting held September 8-9, 2022, and Special Meetings Held September 13, 15, 17, 20, 30 and October 14, 2022, were approved.

Upon motion by Trustee Dickey and second by Trustee Harriman, the following committee items were reported and approved by the full Board:

3.1 Approval of KPMG's Financial Statement Audit of UAMS for the year ended June 30, 2022, and the Government Auditing Standards Opinion on Internal Control over Financial Reporting:

The committee reviewed and approved KPMG's Financial Statement Audit of UAMS for the year ended June 30, 2022, and the Government Auditing Standards Opinion on Internal Control over Financial Reporting.

3.2 Approval of Fiscal Year 2023 Audit Plan Update Report:

The Fiscal Year 2023 Audit Plan Update Report was reviewed and approved. The update included the Audit Plan Update, the Strategic Audit Risk Assessment Report, Internal Audit Reports completed since the last meeting, the Follow-Up Report on Prior Audits, and External Audit reports received and reviewed during Fiscal Year 2023.

3.3 Update on Losses Identified through the Internal Audit Process:

The committee reviewed the Loss Tracking Report Schedule which shows audit reports presented to the Committee during the past year as well as any reports where the case is still active, and a final resolution has not been determined.

Report on University Hospital-Board of Trustees Joint Committee Meeting Held November 15, 2022:

Trustee Nelson reported that the University Hospital-Board of Trustees Joint Committee met on November 15, 2022, and moved that the actions of the Committee, which included approval of the minutes of the meeting held September 8, 2022, be approved by the Board. Upon motion of Trustee Eichler and second by Trustee Harriman, the following committee items were reported on and approved by the full Board:

4.1 Approval of the Safety Management and Emergency Preparedness Report, UAMS:

Dr. Michelle Krause presented the Safety Management report for July 2022 to September 2022 and the Emergency Preparedness report for September 2022 - October 2022. Dr. Krause reported crimes against persons increased slightly during the first quarter.

Two active shooter exercises to test UAMS' ability to respond were conducted, one on the main campus and the second on the Northwest Campus. The Arkansas Department of Health and the Federal Emergency Management Agency will be conducting a drill with UAMS Emergency Department, this is a requirement of UAMS' continued status as the secondary receiving hospital for incidents/accidents occurring at Arkansas Nuclear One. Emergency Preparedness is working with the UAMS trauma team, local response agencies and Catholic High School to conduct a drill exercise involving an active shooter and mass casualty events to prepare staff to respond to this type of incident and to assist in the recertification of UAMS as a Level One Trauma Center.

4.2 Approval of the UAMS Medical Staff Bylaws, Rules and Regulations, UAMS:

Dr. Michelle Krause presented the Medical Staff Bylaws, Rules and Regulations for review and approval as required by The Joint Commission. The changes reflect statutory, organizational and regulatory changes.

4.3 Review of the Institute for Digital Health & Innovation, UAMS:

Dr. Joseph Sanford provided an update on the UAMS Institute for Digital Health & Innovation (IDHI) which encompasses the integration of digital tools and technologies into clinical care and healthcare settings. Interventions such as telehealth reduce healthcare-related costs, travel, wait times and overall disparities in care.

4.4 Review of the Quality, Experience and Safety Report, UAMS:

Dr. Michelle Krause reviewed the UAMS Quality, Experience and Safety Report. She reported Vizient released annual rankings and star ratings for Academic Medical Centers (AMC) in September 2022. UAMS was ranked 75th out 107 and achieved a three-star rating. Healthcare Acquired Infections have increased slightly. UAMS' mortality index has steadily improved due to the Inpatient Hospice Services, Inpatient Sepsis Protocol and documentation education and improvement efforts.

4.5 Review of UAMS Da Vinci Robotic Surgery Program, UAMS:

Dr. Conan Mustain provided an update on the Da Vinci Robotic Surgery Program.

4.6 Review of the Clinical Enterprise Key Indicators, UAMS:

Ms. Amanda George reviewed UAMS Integrated Clinical Enterprise Key Indicators for the period ending September 30, 2022.

4.7 Chief Executive Officer's Update, UAMS

Chancellor Cam Patterson provided an update on construction for the main campus and Northwest Arkansas campus, and Dr. Michelle Krause provided an update on third quarter projections for the Vizient benchmark which is predicted to be 4 out of 5 stars.

5. Report on Academic and Student Affairs Committee Meeting Held November 15, 2022:

6. Report on Agriculture Committee Meeting Held November 15, 2022:

Chair Fryar reported that the Agriculture Committee met on November 15, 2022 and that Vice President for Agriculture Deacue Fields presented a video which highlighted the 4-H events that have recently taken place and highlighted information about the partnership with the University of Monticello, including shared positions and programs. The video also highlighted the County Agent Internship Program, which included interviews with one of the County District Directors and one of the interns, who is also a student at UAM. Dr. Fields mentioned the struggle to recruit and retain County Agent positions due to increased competition for other jobs and higher salaries, and how this internship program will help young people get interested in a county agent position. Upon motion of Trustee Fryar and second by Trustee Harriman, the report was accepted.

7. Report on Athletic Committee Meeting Held November 15, 2022:

Trustee Cox stated that the Board heard a report from Chancellor Phillip Wilson on the Wrestling Program at the University of Arkansas at Rich Mountain. Upon motion of Trustee Cox and second by Trustee Harriman, the report was accepted.

8. Report on Buildings and Grounds Committee Meetings Held November 16, 2022:

Chairman Fryar reported that the Buildings and Grounds Committee met on November 16, 2022. Chairman Fryar moved that the actions of the Committee be approved by the Board; Trustee Harriman seconded, and the following resolutions were adopted:

8.1 Approval of the Acceptance of a Gift and the Naming of the "Arkansas Corn and Grain Sorghum Producers Building," AGRI:

WHEREAS, the Arkansas Corn and Grain Sorghum Board was established to provide Arkansas' growers of these major commodities with the tools and resources necessary to improve profitability and sustainability; and

WHEREAS, corn production is vital to Arkansas' farm economy, providing valuable feed for livestock, feedstock for biofuels, food for human consumption, and many other uses; and

WHEREAS, corn production has been increasing in Arkansas for the past twenty years, moving Arkansas into the top twenty states in the US for corn production, and placing corn behind only soybeans and rice in the state for crop cash receipts; and

WHEREAS, Arkansas is one of the top grain sorghum producing states in the US, growing a resource-conserving crop renowned for its tolerance to production on all types of land and environmental conditions, its versatility as a food, feed, and biofuels grain, and its importance in the agricultural export market; and

WHEREAS, research and extension expertise supported by Arkansas' corn and grain sorghum producers and provided by the University of Arkansas System Division of Agriculture has been instrumental in the success of corn and grain sorghum production and marketing in Arkansas; and

WHEREAS, the legacy of commitment and cooperation between the Arkansas Corn and Grain Sorghum Board and the University of Arkansas System Division of Agriculture is a model not just in Arkansas, but in the US;

8.9 <u>Presentation of Revised Project Proposal and Budget Increase for the Administration Building Project, ASMSA:</u>

Director Corey Alderdice, Arkansas School for Mathematics, Sciences and the Arts, informed the Board that the Campus Administration Building construction project costs have increased from \$3.5 million to \$5.25 million after all construction bids were submitted. Bids were higher than anticipated due to a slightly larger footprint for the facility, additional ADA elements deemed appropriate for the long-term needs of campus, as well as ongoing labor, materials, and other inflationary pressures stemming from the pandemic. ASMSA has been able to absorb this unexpected cost increase through conservative budget planning and plan to move forward with the project which will allow ASMSA to consolidate various administration functions into a single building, transfer faculty from the Pine Street Wing of the hospital complex to their primary academic building and improve ADA accessibility between the residential and academic zones of

campus. Moving forward ensures that the school remains able to vacate the hospital complex in mid-2024 as originally planned. Both ASMSA and the City of Hot Springs see great urgency in reaching this critical stage in the campus transformation and fulfillment of the City's 2010 pledge.

WHEREAS, his legacy extended to the UAPB Golden Lion athletics program which made advancements under his watch including the completion of the Golden Lion Stadium in 2000 and the Tori Hunter Baseball and Softball Complex in 2011; and

WHEREAS, throughout his tenure as Chancellor, Dr. Davis showed concern for students at UAPB in all aspects of student affairs and in providing educational excellence; and

10.3 Coach Lance Harter

WHEREAS, Coach Lance Harter has served 34 years as the women's cross country and track and field coach at the University of Arkansas, Fayetteville, and will retire from the position on June 30, 2023; and

WHEREAS, Coach Harter is the most successful women's cross country and track and field coach in U of A and Southeastern Conference history, having led his teams to six NCAA Championships and 43 SEC Championships; and

WHEREAS, his NCAA titles have occurred in each sport, including three at NCAA Indoor, two at NCAA Outdoor and one at NCAA Cross Country, including becoming only the second program ever to win the NCAA Triple Crown in 2019; and

WHEREAS, Coach Harter has coached Razorback student athletes to 637 All-American honors, including 152 individual athletes and 458 First-team All-American selections; and

WHEREAS, Coach Harter is an eight-time winner of NCAA Coach of the Year, a 44-time winner of SEC Coach of the Year, and a member of the USTFCCCA Coaches Hall of Fame; and

WHEREAS, Coach Harter's honors culminated in the U of A women's cross country and track field program being named the 2022 USTFCCCA Terry Crawford Program of the Year; and

WHEREAS, Coach Harter leaves a lasting legacy of success both on the track and off and has earned the enduring gratitude of Razorback student athletes and fans for taking the Razorback women's cross country and track and field program to new heights during the past thirty-four years;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE UNIVERSITY OF ARKANSAS THAT the Board expresses its heartfelt appreciation and admiration for Coach Lance Harter and congratulates him upon his retirement after three decades of unprecedented success as coach of the Razorback women's track and field and cross-country programs.

BE IT FURTHER RESOLVED THAT the Board directs that this resolution shall be spread upon the minutes of this meeting and that a copy be transmitted to Coach Harter.

11. Campus Report: Dr. Peggy Doss, Chancellor, UAM:

Dr. Peggy Doss discussed the uniqueness of UAM and what the institution offers to the region. As an open-admission university with a main campus and two colleges of technology, UAM is committed to improving college attainment rates in Arkansas and making higher education accessible to students in the region and beyond. UAM prides itself in offering an affordable, quality education to many first-generation college students, which

make up 49% of the student body. The newly formed UAM Enrollment Task Force comprised of staff from across campus is collaborating with the marketing department to produce recruitment materials and grow enrollment. Over the past two years, the UAM Colleges of Technology have received \$5,000,000 for workforce development. UAM has the only accredited forestry program in the state and received \$842,000 to its base to establish the Arkansas Center for Forest Business, located in the College of Forestry, Agriculture and Natural Resources. UAM also has several renovations projects underway. including the Agriculture Building, science laboratories, a greenhouse and an athletic performance center. UAM is playing a significant role in preparing students for highshortage careers like public-school educators and healthcare professionals, and its new Master of Science in Nursing in Public Health officially begins in January 2023. As part of a new partnership, Drew Regional Health Systems in Monticello is awarding scholarships to UAM nursing students, and in return, the nursing students are employed by the local hospital upon graduation, addressing the nursing shortage. With 150 unique partners, UAM is committed to partnerships and collaborations that enhance opportunities for students and maximize campus resources. While discussing new partnerships, Dr. Doss invited Waterfowl Habitat and Recreation Management graduate certificate student Elijah Wojohn to present on what attracted him to UAM's new program and his experiences in studying with UAM's new partner, the Five Oaks Research Center at Five Oaks Duck Lodge. The center provides a unique learning environment and outdoor learning laboratory for students of forestry and waterfowl management. Wojohn said that program exposes students to a wide variety of waterfowl management professionals to learn directly from them and provides him with the expertise that will help him to pursue a career managing waterfowl in the private or public sector. UAM is also exploring a partnership between the UAM Forestry program and the University of Arkansas Fay Jones School of Architecture. UAM announced a capital campaign to fund an Agriculture and Forestry Event Center to host intercollegiate rodeos, FFA and 4-H events, high school rodeos, agriculture and forestry expos, equine events, cattle auctions and community events and is pursuing funding to construct a new art facility. In January 2023, UAM and National Park College will announce an exciting, oneof-a-kind partnership that will serve the students of Garland County through a unique campus within a campus concept. By exploring these and other future projects, partnerships and initiatives, UAM will continue to strive to serve the region and the state of Arkansas.

12. President's Report: Donald R. Bobbitt, University of Arkansas System:

President Bobbitt expressed appreciation to Chancellor Peggy Doss and UAM's faculty and staff for hosting the Board and the UA System staff and for providing the special musical event for their enjoyment. He then recognized General Counsel JoAnn Maxey's retirement effective January 5, 2023. He concluded his report by recognizing and congratulating Dr. Charles Robinson as the new chancellor of UA Fayetteville, effectively immediately, and Dr. Summer DeProw, new chancellor of UA-PTC effective January 1, 2023.

13. Campus Security Presentation: University Police, UAM:

General Counsel JoAnn Maxey introduced Lt. Rodney Pickens of the UAM University Police Department. Lt. Pickens then presented a brief overview of training and drills that took place at UAM for various departments in the last 12 months. He also covered the UPD's presentation on active shooter situations, which is shown to all new students and employees of UAM. Lt. Pickens showed two short videos as well as the federally recommended steps for personal safety: avoid-deny-defend. He concluded his presentation with national statistics for active shooter situations involving higher education and training that UAM-UPD officers attended.

14. Update on Faculty Promotion and Rank Policy, UA-PTC:

Chancellor-elect Summer DeProw, University of Arkansas – Pulaski Technical College, presented a draft of their Promotion and Rank policy for the Board's information.

BRIEF DESCRIPTION OF ADDED PROGRAM:

Students in the English B.A. professional writing and creative writing concentrations, the renamed Professional Writing Minor, or the Creative Writing minor will be able to choose a Certificate of Proficiency in Content Creation, Editing, and Publishing that that will enable them to position themselves as experts in these areas of professional writing.

DOCUMENTATION OF NEED:

The Certificate of Proficiency in Content Creation, Editing, and Publishing will enable students to enhance their abilities in developing relevant, effective, and professional content across digital platforms. Professional editing for the web and written digital content creation is a growing field. It will offer students wishing to go into technical writing, editing, freelance writing, social media content creation, and other related fields a competitive edge. This Certificate of Proficiency will provide students with skills in critical thinking, research, and digital, multimodal, oral, and written communication. Specifically, students will gain focused skills in content creation and curation in audio, digital, and written forms. The specific content area knowledge will prepare students for jobs in editing, content creation, publishing, and writing. Students may enroll either via meeting program prerequisites or by instructor consent. Available area job openings in this field would have people working with business/corporations, media organizations, educational institutions, and city organizations. A survey of recent job postings in Arkansas and Oklahoma shows 495 job postings for content creation, content writing, content management, and content production with a concentration of openings in Bentonville, Fayetteville, Little Rock, Tulsa, and Oklahoma City. The standard requirement is a BA with some experience in content creation, Adobe Suite, graphic design, and CSS/PHP/HTML as well as editing, writing, and communication skills.

Given the student interest our among our current population of 76 majors, the projected number of Certificate of Proficiency enrollments and graduates in Content Creation, Editing, and Publishing is:

BRIEF DESCRIPTION OF ADDED PROGRAM:

Students in the English B.A. professional writing and creative writing concentrations, the renamed Professional Writing Minor, or the Creative Writing minor will be able to choose a Certificate of Proficiency in Grant and Non-Profit Writing that that will enable them to position themselves as experts in this area of professional writing. This is one of eight certificate of proficiencies we are adding. Each of these certifications will better enable students as they pursue graduate studies, seek other positions that require specialization, or differentiate themselves on the job market. No other school in the UA System offer undergraduate certificates of proficiency in any of the areas we are proposing.

DOCUMENTATION OF NEED:

The Certificate of Proficiency in Grant and Non-Profit Writing focuses on strong editing and argumentation skills, and it will offer a competitive edge to students who do not yet have experience in securing funding as they enter or return to the workforce in nonprofit areas (the voluntary sector) and/or government run companies or corporations (the public sector). Those who are already working in voluntary or public sectors within the Fort Smith region and/or wish to develop their own grant writing business will benefit from a structured yet flexible curriculum that encourages students to focus on areas of personal interest and professional development specific to their needs while also helping area businesses meet their needs. This Certificate of Proficiency will provide students with skills in critical thinking, research, and digital, multimodal, oral, and written communication. Specifically, students will gain long term skills in composing clear, concise arguments and in the specifics of grant writing. The specific content area knowledge will prepare students for jobs in education and related fields such as corporate training and charter schools, libraries, and non-profit work. Available area job openings in this field would have people working with business/corporations, educational institutions, hospitals, city organizations, and tribal organizations. Students may enroll either via meeting program prerequisites or by instructor consent.

The Bureau of Labor statistics notes that the job growth for people pursuing careers in fundraising, which includes grant and non-profit writing, is 11% faster than average, with 105,800 jobs available in 2021. A survey of recent job postings in Arkansas and Oklahoma shows 1596 job postings for grant writing, non-profit writing, and grant management with a concentration of job openings in Fayetteville, Little Rock, Tulsa, and Oklahoma City. The standard requirement is a BA with some experience in grant writing.

BRIEF DESCRIPTION OF ADDED PROGRAM:

Students in the English B.A. literary and cultural studies, professional writing, and creative writing concentrations, the renamed Literary and Cultural Studies Minor, the renamed Professional Writing Minor, the Creative Writing minor as well as students in other areas of study will be able to choose a Certificate of Proficiency in Pre-Law Studies that that will prepare them for the rigors of the LSAT and law school.

DOCUMENTATION OF NEED:

While Pre-Law is not a major at any institution, we need to provide students with a path to understanding legal studies and the writing, argumentation, and reasoning skills necessary for law school while also preparing them for the LSAT or GRE. It would also prepare students for work in legal offices, state and local government positions, or other areas where some legal expertise might be of use. Students interested in Pre-Law are advised to major in disciplines such as English, History, Political Science, and Philosophy, and the certificate of proficiency includes courses from these disciplines that will best prepare students for that course of study. It also includes courses from Business, Speech Communication, and Criminal Justice as students from those majors also matriculate to law school from UAFS.

The ENGL 4503 Legal Rhetoric course and PHIL 3103 Reasoning Across the Disciplines will help students meet the logical reasoning and analytical skills necessary for the LSAT. Specifically, the Certificate of Proficiency will provide students with skills in argumentation, oral and written communication, and legal reasoning. The specific content area knowledge will prepare students for jobs in legal studies or prepare them for law school. Students may enroll either via meeting program prerequisites or by instructor consent.

While law school costs can be prohibitive, a study of the last five years of our students who registered through the Law School Admissions Council (LSAC) shows that our students by far and large attend law school in Arkansas. Thirteen attended the University of Arkansas Law School and four attended the University of Arkansas at Little Rock William H. Bowen School of Law. Both institutions offer reasonable in-state tuition at \$16,188 and \$16,031 per year, respectively. Both also offer grants to help with tuition costs. According to Public Legal, as of 2020, 80.2% of graduates from the University of Arkansas and 70.8% of graduates from UALR are employed ten months after graduation.

BRIEF DESCRIPTION OF ADDED PROGRAM:

Students in the English B.A. literary and cultural studies, professional writing and creative writing concentrations, the English Minor, the renamed Professional Writing Minor, the Creative Writing minor as well as students in other areas of study will be able to choose a Certificate of Proficiency in User Experience (UX) that that will prepare them for work in this growing technical field.

DOCUMENTATION OF NEED:

The UX Certificate of Proficiency will enable students to pursue employment in this growing field that helps make technology easier to use for people. It blends skill sets in writing, graphic design, and media production. Jakob Nielsen (2017) predicts that there will be "100 million UX professionals in the world by 2050." Unlike other careers in technology and information, the skills needed to be a successful UX professional exist at the intersection of a number of fields. Krause and Rosala (2020) note, "soft skills are still the most important skill set in gaining a job in the field and succeeding in it."2 An examination of current professional UX certifications confirms an emphasis on building these "soft skills" for existing IT professionals-including skills in qualitative research, graphic design, and technical writing. University of California San Diego and University of Texas at Austin, among other universities, offer this kind of certification. The University of Arkansas at Fayetteville offers this kind of programming at the graduate level, but we feel students would benefit from certification at the undergraduate level so that they can immediately enter the workforce. The UX certification at UAFS seeks to prepare students for careers in UX and for jobs where UX knowledge is necessary to compete. The UX certificate supports the cross and interdisciplinary literacies needed to enter the field of UX, grounding student skill sets in research, design, and writing. The specific content area knowledge will prepare students for jobs in web development, digital design, user experience, and technical writing. Students may enroll either via meeting program prerequisites or by instructor consent.

PROJECTED ENROLLMENT:

Given the student interest our among our current population of 76 majors and expressed outside interest in these certificates of proficiency, the projected number of Certificate of Proficiency enrollments and graduates in User Experience.

• The average Certified Occupational Therapist Assistant salary in Arkansas is \$58,315 as of September 26, 2022 (salary.com), but the range typically falls between \$52,536.00 and \$64,059. Salary ranges can vary widely depending on the city, community, and many other important factors, including education, certifications, additional skills, and the number of years of experience practicing in this career.

3. Expected salary after 5 years

- It is difficult to predict salaries after five years. This program sets students on a pathway
 for possible admission to an Occupational Therapy Program (these require a
 baccalaureate degree before gaining entry), and some find leadership in administrative
 positions.
- According to the Occupational Therapy Assistant Salary Guide (2022) experienced OTAs do earn slightly more over time than when they entered the career ladder. However, it also indicated that this occupation has higher starting salaries than many two-year degrees graduates earn. OTAs do not have significant raises in salary.

4. PROGRAM SUMMARY:

PCCUA is proposing a new Associate of Applied Science (AAS) program to prepare students to become Certified Occupational Therapy Assistants (COTA). With a majority female student body PCCUA has many women enroll with the dream of becoming a nurse, and the College has strong Practical Nursing and Registered Nursing programs. Acceptance into these high demand programs is; however, limited, and students who are not accepted often have little awareness that many other allied health jobs are also available in the communities and cities where many nursing graduates work including Memphis, Batesville, Clarksdale, and even Oxford, Mississippi; in communities in the College service area, and Little Rock for the Stuttgart and DeWitt campuses. By developing an OTA program, the College will provide access to another high-demand, high-pay option for qualifying students.

Employment is projected to grow 25% from 2021 to 2031 which is much faster than the average 3% for all occupations according to the *Occupational Outlook Handbook* (2022) published by the U.S. Bureau of Labor Statistics. The average Certified Occupational Therapy Assistant's salary in Arkansas is \$58,315 as of September 26, 2022. *Salary.com.* and *Zip Recruiter* show much higher salaries in both Arkansas and Tennessee. The salary range typically falls between \$52,536 and \$64,059. However, PCCUA found local salaries much lower. Salary ranges can vary widely depending on the community or city where a person works. This career requires clinical experience as part of the preparatory curriculum for the AAS.

5. NEED FOR THE PROGRAM:

The PCCUA 2020-25 Strategic Planning efforts included all college employees. During that process, adding another allied health program was identified as a need. Three programs were identified as possible options; however, the selection of the OTA program was based on the fact that there are no two-year programs located close to PCCUA. Colleges close to PCCUA offer radiology technician, dental assistants, and respiratory therapy programs; therefore, OTA was the best choice to accommodate a regional need in Eastern Arkansas. As a result of this strategic planning, PCCUA wrote and received a Title III grant requesting support for two new programs, one of which is Occupational Therapy Assistant. The Title III grant was approved, and it will cover all start-up costs for the program for three years. This new program funded entirely by external dollars is a remarkable opportunity for PCCUA.

The OTA programs have a strong projected growth in the region, Arkansas, and the nation. A new Occupational Therapy Assistant program would provide an associate degree for struggling students in the Delta who desire to improve the quality of their lives.

The OTA program will meet a regional and state workforce need and increase enrollment at PCCUA. The high-demand, high-paying jobs will appeal to students. Additionally, the program provides graduates with the skills they need to get a job offering economic security. New jobs, says the American Occupational Therapy Association, "are expected to total 16,300 nationally between 2019 and 2029" according to the *Job Outlook for Occupational Therapy* (2022).

Agencies that responded to the survey regarding the need for OTA follows. In addition to the information included in the chart, there were questions concerning required soft skills in which all survey respondents indicated that interpersonal communication and written/oral communication analysis would be skills that were necessary for program participants. In addition, all survey respondents indicated that program participants would need to possess skills necessary to be an independent worker but also be able to work as a valuable member of a team. Fourteen of the respondents indicated that program participants would need skills to manage conflict as well as planning and organizational skills; six indicated need for computer applications and leadership/Initiative skills while five indicated a need for analytical reasoning and computer programming skills and two indicated they will need skills in teaching and data.

However, the program will be Pell eligible and about 67% of our students receive Pell assistance. PCCUA offers the Great River Promise, a guarantee of assistance for any graduate from a public school in our community who does not qualify for other scholarship assistance. The College Foundations and several community foundations support scholarships for students in allied health fields. This fall numerous allied health and nursing scholarships were awarded. There were 14 PCCUA technical scholarships, 38 Foundation scholarships, 15 Helena Health Foundation scholarships, and 13 private donor scholarships to students enrolled in Allied Health and nursing programs. Approximately 80 students received tuition and book assistance. These scholarships generally go to students who have no other source of financial support. We have seven allied health programs (four are certificate programs) and the OTA would add a fourth associate program. It is likely that if a student is accepted into the program, if there is a financial need, it will be met.

Describe what need the proposed program will address and how the institution became aware of this need. Indicate which employers contacted the institution about offering the proposed program.

Several nursing faculty brought the idea of the program forward at a college-wide strategic planning session. The need for OTAs is important for local nursing homes and centers serving disabled children. Many agencies can't afford to hire multiple occupational therapists but can afford to pay the much lower salary of OTAs working under the supervision of an OT. Both the Great River Educational Cooperative and two nursing homes identified that OTAs were in demand.

Most allied health and nursing graduates do not work in our service are. In fact, nursing graduates, MLT graduates, truck drivers, and many other career graduates live in the counties but do not work in our communities. PCCUAs most successful programs are those with a high demand, high wage which allow the graduate to commute to a community offering jobs in that career. This is the story of all rural community colleges. It is one reason the College has invested much research into the development of an OTA program.

Most employers wanted to be sure that the program focused on field experiences that gave students the opportunity to work in the OTA setting. Additionally, many were interested in making sure that students had the soft skills needed to navigate student to student, student to patient/client, and colleague to college interactions. Critical thinking and conflict resolution were also important to potential employers. Finally, many wanted to make sure students learned and applied appropriate interventions when working with children and adults, especially geriatric adults.

7. FACULTY:

As previously mentioned, the entire first three years of the OTA program will be funded through a United States Department of Education Title III grant awarded in the Fall of 2022. The proposed Occupational Therapy Assistant program will require the following staff and instructors: **Title III Project Director (1.0 FTE)** Reporting to Chancellor Pinchback for **sufficient authority as required by Title III**, the Project Director administers the Title III grant and Michelle Waites is that Director. The OTA program will have access to one (1.0 FTE) employee designated to assist with distance learning. Certain theory courses will be offered via distance for students with transportation and other attendance barriers. Some courses will be offered hybrid and this person will assure that students navigate all aspects of technology and online activity with skill. These two positions are part of the Title III grant and are not directly related to the implementation of the OTA program.

PCCUA will need to hire one (1.0 FTE) Occupational Therapy Assistant Specialist/instructor who will teach the OTA courses. Additionally, one (1.0 FTE) academic fieldwork coordinator will be added to the program. This position will not be one person but four part time employees. Before Year Two of the program implementation, PCCUA will add a second (1.0 FTE) OTA instructor to work with the second-year cohort. Under the supervision of the Title III Coordinator, the Distance Learning/Project Assistant will assist OTA and other students with technology needs.

Reporting to the Title III Project Director and the Dean of Allied Health in Nursing, the Occupational Therapy Assistant Specialist/Instructor will plan, pilot, teach, and evaluate a competency-based Occupational Therapy Assistant program.

Reporting to the OTA Specialist, four adjunct instructors will serve as the Academic Fieldwork Coordinators and will oversee all aspects of clinical lab instruction.

Year Two of the program will require adding a second faculty member.

8. NEW PROGRAM COSTS:

Almost no new costs are required for the OTA program implementation because the program is fully funded through a Title III grant. However, a table of expenses Title III funds will cover has been provided.

10. SPECIALIZED REQUIREMENTS:

PCCUA intends to seek accreditation for the Occupational Therapy Assistant program by the Accreditation Council for Occupational Therapy Education (ACOTE) of the American Occupational Therapy Association (AOTA). Graduates of the program can sit for the national certification examination for the occupational therapy assistant program administered by the National Board for Certification in Occupational Therapy, Inc. (NBCOT).

11. SIMILAR PROGRAMS:

OTA education is offered at only five locations in Arkansas. These institutions and their distance from Helena-West Helena are Arkansas State University (106 mi.), Arkansas Tech University- Ozark Campus (231 mi.), Baptist Health College Little Rock/UA-Pulaski Technical College (219 mi.), Cossatot Community College of the University of Arkansas (258

mi.), and South Arkansas Community College (184 mi.). A for-profit entity, Concorde Career College, is located 79 miles away, in Memphis but charges \$46,010 for books and tuition, compared to PCCUA's annual tuition of just \$2,190 per term. For low-income, place-bound PCCUA students, it is clear that an OTA program at the College would offer their best chance for a high-demand, high-pay career as an Occupational Therapy Assistant.

As part of our ongoing commitment to efficiency in the operation of the University of Arkansas System, enclosed is a summary of our annual five-year review of academic offerings approved by the Board of Trustees. This review is consistent with language in Board resolutions calling for review of approved academic programs after five years to determine if they are meeting enrollment and budgetary expectations. Programs not meeting expectations may be discontinued, or campuses may choose to implement plans to improve them and submit them for re-review at a later date. This process began in 2017 with a review of all academic programs approved during 2012. The current report provides a review of the 2017 academic agenda items.

Enclosed is a summary of 58 new academic offerings that were approved at 13 campuses during the 2017 calendar year. There are additional updates on programs from previous reports that were placed on improvement plans and held over for continual review. The summary notes programs that have met or exceeded expectations, those that are being placed on improvement plans, and those that have been or will be discontinued for lack of performance. For those 2017 programs that are undergoing improvement plans, we will review them again at the January 2025 meeting to determine their long-term viability going forward.

I recommend approval of the enclosed report. Approval of the report will serve as Board approval for those programs that are being discontinued but have not been deleted as of the report date.

1. PROPOSED FUNCTION OF PROJECT

Yocum Hall is part of a matching pair of high-rise dormitories built at the edge of McIlroy Hill in the early 1960s. Its twin, Humphreys Hall was built in 1961, with Yocum Hall following in 1963. Both buildings share the same modernist design language, which includes an exposed concrete structure, a series of deep concrete overhangs, diamond-patterned cast-concrete spandrel panels, brick end walls, generously-sized sliding windows, and entrance terraces shaded by expressive folded-plate canopies. Yocum Hall houses 530 students in double rooms, which makes it one of the largest residence halls on campus.

Since its construction, the building has not been substantially renovated. A 2011 project focused on upgrades to some building systems, as well as selective asbestos abatement, but did not address larger issues of capital renewal and deferred maintenance. This project is intended to—over the course of a series of construction phases—address all remaining building systems and finishes to conclude the full renovation of the building. Exterior work will consist of roof replacement, tuck pointing, masonry sealing, repair of concrete ledges and canopies, and replacement of existing windows with energy-efficient units. Because the building is eligible for the National Register of Historic Places, exterior work will be done according to preservation best practices. The interior scope will include the introduction of new communal spaces, accessibility improvements, door and hardware replacement, new finishes like paint and flooring, and new furnishings throughout. All remaining asbestos will be abated, and all original building systems not included in the 2011 project will be evaluated for replacement or rehabilitation.

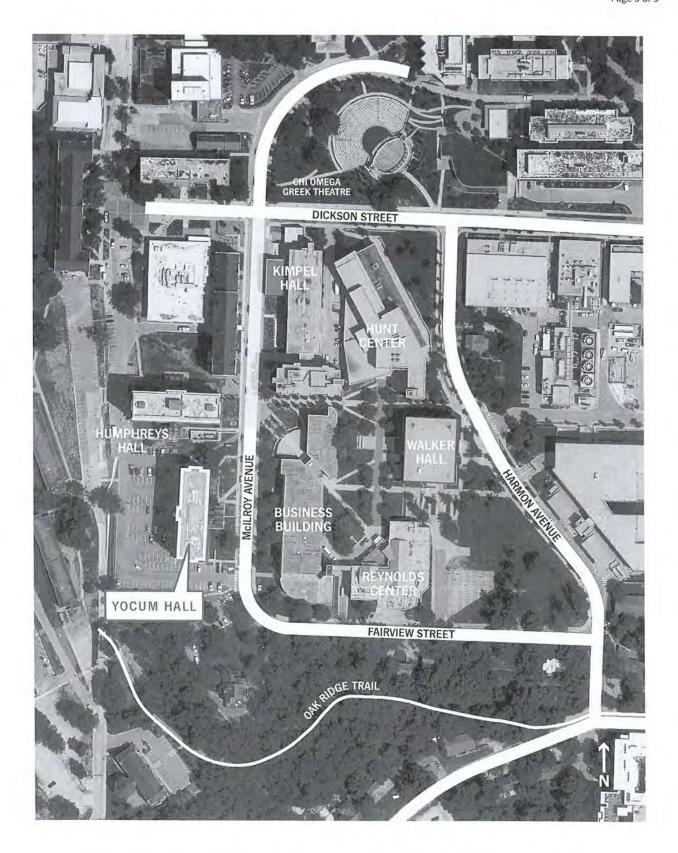

Reid Hall is part of a matching pair of high-rise dormitories built in the campus's Maple Hill district in the mid-1960s. Its twin, Hotz Hall, was built in 1964, with Reid Hall following in 1966. Both buildings share the same sparse modernist design language, which includes an exposed concrete structure, a series of deep concrete overhangs, orange brick end walls, and generously-sized sliding windows. Reid Hall houses 459 female students in double rooms, which makes it the largest residence hall for women on campus.

Since its construction, the building has not been substantially renovated. A recent small project has improved air quality by providing additional fresh air to all corridors. Apart from this targeted mechanical system upgrade, larger issues of capital renewal and deferred maintenance have not been addressed. This project is intended to replace all of the original single-pane aluminum windows with new units. The new insulated windows will provide greater comfort to the residents and lower the operational costs of the building. Removal of the original windows will require limited asbestos abatement along the edge of the ceiling, leaving the remaining material to be removed as part of a more comprehensive interior renovation.

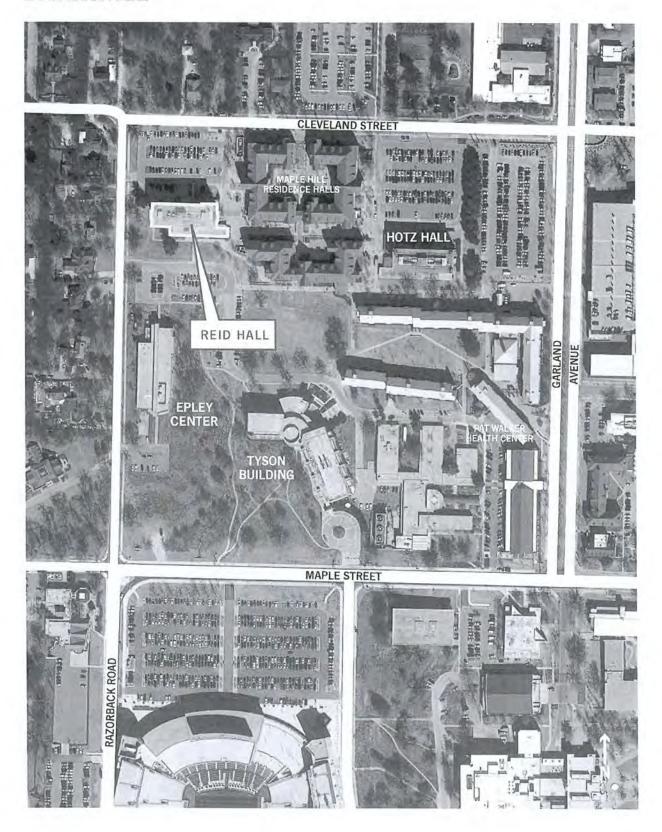

1. PROPOSED FUNCTION OF PROJECT

The Arkansas Union is situated at the center of the University of Arkansas campus, where it provides a community hub for students, faculty, staff, and visitors. This project will improve the function and visibility of spaces for a number of student-focused uses that are housed in two areas of the building: the Multicultural Center on the fourth floor of the west wing, and the Center for Student Organizations on the second level of the east wing. Collectively, these two areas provide offices, classrooms, workrooms, quiet study, meeting rooms, tutoring spaces, etc. for the College Access Initiative, the Academic Enrichment Program, the Office of Student Activities, Student Affairs Development and Communication, Associated Student Government, New Student and Family Programs, Graduate-Professional Student Congress, Registered Student Organizations, University Programs, and Student Organization Outreach and Involvement Experience (SOOIE).

The Arkansas Union interior fit out for student organizations will better use existing space to create an optimal fit for the current operation of the various student organizations, all of which have grown along with the increase in student enrollment. It will improve the character of the space through new furnishings, finishes, and lighting. And, importantly, it will help clarify movement and access in these areas, which have become difficult to navigate through years of incremental modifications.

In addition, the project will investigate water infiltration that currently mainly affects the Multicultural Center, but could be more systemic. The design team will evaluate the building envelope, including the balconies, and recommend repairs.

This project will involve interior spaces in the east and west wings of the building, as well as areas of the façade where water infiltration has been noted.

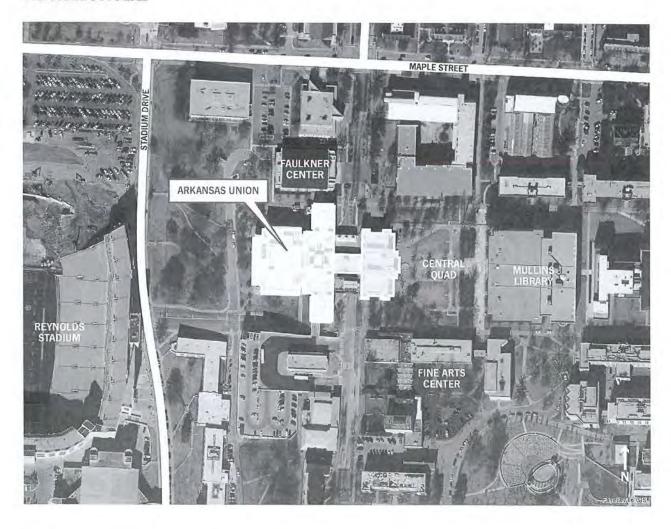

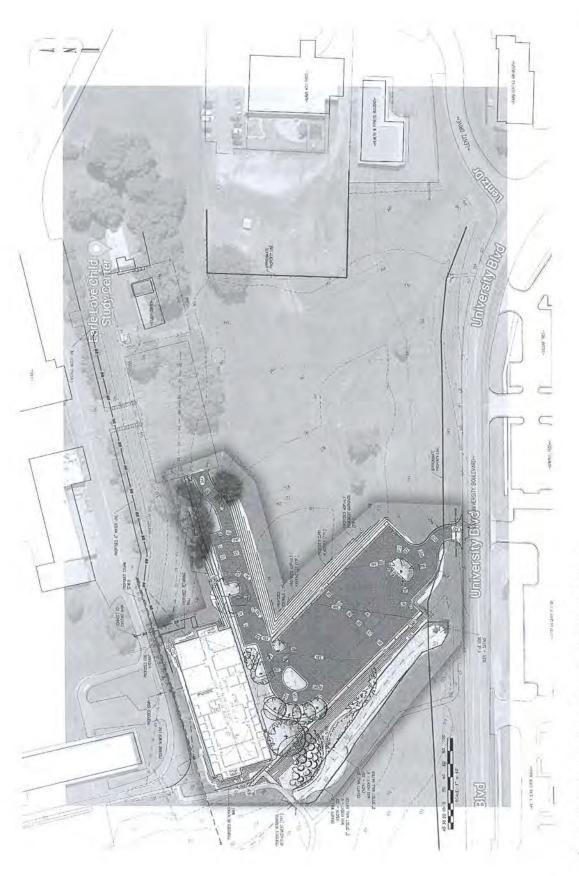

Name of Proposed Facility: Allied Health and Science Center

- 1. The function of this project is for new construction serving as the next priority facility as per the UACCM campus master building plan (attached exhibit A link section 2.3.c, pg 22).
- 2. Proposed facility location/map (attached exhibit B) and project description (attached exhibit C).
- 3. Total estimated project cost, including construction and design, land acquisition, and fixtures is \$16,000,000.
- 4. Total estimated cost of furnishings is \$1,000,000.
- 5. Estimated time to substantial completion is 30 months commencing January 2023 with substantial completion June 2025.
- 6. Parking plan to support new facility is available on attached exhibit B. New parking also adjoins existing campus parking lot to the east superimposed on exhibit B map.
- 7. This is not a phased project.
- 8. The source of project funds include as follows:
 - a. UACCM Reserves \$3,000,000
 - b. EDA Infrastructure/Site Grant \$2,000,000
 - c. Other grant funds \$2,000,000-\$4,000,000
 - d. Private donations \$1,000,000
 - e. Tuition & Fee Revenue Bonds \$6,000,000-\$8,000,000*

*UACCM has a single outstanding Bond Series 2016; thus ample current debt capacity exists in the event c and d projections above fall short. Grant and Private funds are logically being sought first.





UACCM Allied Health and Science Center

The University of Arkansas Community College at Morrilton (UACCM), a campus included in the University of Arkansas System and governed by the Board of Trustees of the University of Arkansas, is seeking to construct an Allied Health and Science Center to consolidate the school's health professional training programs from a number of smaller existing buildings on the UACCM Campus to a new, state of the art facility. The nursing program in specific has outgrown their current educational space (which was a renovated 1963 administration building) due to increasing enrollment. UACCM successfully secured an infrastructure construction grant from the Federal Economic Development Administration in the amount of \$2,000,000 in July 2022.

With the construction of a new Allied Health and Science Center on the campus of UA Community College Morrilton, the campus forecasts currently offered Allied Health programs have the potential for up to a 66% student expansion in the Registered Nursing, Licensed Practical Nursing, Emergency Medical Technician, and Certified Nursing Assistant programs combined, based entirely on new and larger facilities.

As well, the new construction would provide space for the addition of multiple new programs suggested by various advisory committee members. These include Certified Medication Assistant, Paramedics, Respiratory Therapists, Medical Office Technology Assistant, and Medical Clinical Assistant. The addition of these programs would provide for up to an additional 100 students annually entering these new Allied Health Programs to produce up to 100 completers each academic year.

These additional trained medical professionals will be an essential part of the regional public health resilience. As the COVID-19 pandemic has demonstrated, a state and local community's ability to respond quickly to public health needs is a vital part of the healthcare ecosystem.

The new facility construction will also add multiple science classrooms and labs replacing current spaces that double as classroom/labs due to space constraints. The new building design provides for increasing current science offerings between existing program expansion and added courses for health science and STEM transfer students.

An indirect, but equally important benefit of the new Allied Health and Science Center is the ability provided to renovate the buildings which currently house the allied health and science programs into other equally needed spaces. Other needs exist for expanding short-term training and micro-credentialing for both credit and non-credit needs in order to respond to other areas of medical workforce shortages such as mental health counselors.

Lastly, the construction of the Allied Health and Science Center along with the expansion and addition of both allied health and science programs will add approximately 18 full- and part-time Instructors, Clinical instructors, and other lab/support employees within the first five years of the opening of the new facility. The stimulus to the economy by way of additional UACCM employment opportunities in the region based on current wages could yield additional salary and benefits packages of up to \$1,000,000 per year. The impact of the additional employment of trained allied health and science professionals upon program completion would be exponential.

Dear Trustees:

In keeping with our ongoing efforts to review and update Board of Trustees and UA System policies to align with current law and practice, enclosed are proposed amendments to two Board policies, and the deletion of one Board policy for your consideration. While the edits to the amended policies appear extensive, they do not make substantive changes as is described in more detail below. These proposed policy revisions were shared with the Chancellors and Chief Executive Officers for distribution on their campuses and posted on the UA System website earlier this month.

The proposed policy amendments include:

- Revised BP 275.1, Title IX Compliance Title IX compliance has long been dictated by BOT policy with directives made to the campuses to implement compliance via campus policies. Because of continued revisions to federal guidelines regarding Title IX, the proposed amendments streamline the Board policy and direct that federal guidance be implemented via campus policies. This will allow campuses to adapt to evolving federal guidance without the need for continual updates to the Board policy.
- Revised BP 620.1, Addition, Deletion, Suspension, Review and Modification of Academic Programs – The proposed amendments re-order the policy to conform with current policy structure and edit the policy to align it with current practices in the system and state regarding academic program review.
- Delete BP 1025.1, Academic Reorganization of UALR This policy was left out of the November 2022 submission of policies that are outdated and no longer necessary. The policy was adopted in 1976 and has not been revised since that time, and academic reorganizations are not considered policy matters.

BOARD POLICY 275.1

TITLE IX COMPLIANCE

I. Purpose

A. The University of Arkansas System and its campuses, divisions and units seek to provide a safe and positive working and learning environment free from all forms of discrimination.

B. This policy is intended to assist all campuses in complying with Title IX of the Education Amendments of 1972 ("Title IX"), which prohibits all forms of sex-based discrimination, harassment, and sexual misconduct in an institution's education programs or activities. Discrimination based upon sex can include sexual harassment or sexual violence, such as dating violence, domestic violence, sexual assault, or stalking, as well as conduct based on sex or sex-stereotyping, even if those acts do not involve conduct of a sexual nature.

II. Establishment of Policies and Procedures

Each campus in the UA System shall develop policies and procedures to assure compliance with the requirements of Title IX and state law regarding discrimination on the basis of sex, including sexual harassment and sexual violence. Each campus shall:

- A. <u>Title IX Coordinator</u>. Appoint a Title IX Coordinator and notify students and employees of the name, title and contact information of the Title IX Coordinator. Campuses may also designate one or more deputy Title IX coordinators, as appropriate to the structure of the campus.
- B. Notices. Publish a notice of nondiscrimination on the basis of sex, including, but not limited to, on the campus website and in any student handbook or similar publication or other appropriate means of dissemination. The notice must state that inquiries concerning the application of Title IX may be referred to the campus Title IX Coordinator or the Office for Civil Rights, U.S. Department of Education. The notice shall also include the contact information for the campus Title IX Coordinator and Deputy Title IX Coordinator, if any. Additionally, the campuses are free to include other information in the notice that may be helpful to an individual such as available campus support services.
- C. <u>Campus Policies</u>. Publish and disseminate its policies prohibiting discrimination on the basis of sex and the procedures for reporting, investigation, and resolution of complaints.

Policies should include a description of the conduct that constitutes sex discrimination, sexual or gender-based harassment, and sexual violence, consistent with applicable federal and state laws, and regulations. All other complaints of discrimination, harassment, or misconduct that do not fall within the jurisdiction of Title IX may be made through other campus policies or procedures.

- D. <u>Training</u>. Provide all employees training on sex discrimination and the campus Title IX policies and procedures to include, at a minimum, the institution's obligation to address sex discrimination, the scope of conduct that constitutes a violation of Title IX policies, and all applicable notification and reporting requirements. Persons who are responsible for implementing or participating in the campus Title IX grievance proceedings must receive enhanced training on the institution's obligations and grievance proceedings and their specific responsibilities, and any other training necessary to coordinate the campus' compliance with Title IX.
- E. <u>Support Measures</u>. Provide support measures and resources for assistance to the parties involved in a complaint as necessary or appropriate.

III. Reporting Obligations

A. <u>Employee Reports</u>. Any campus employee receiving information about a potential violation of the campus's Title IX policy I must promptly notify the Title IX Coordinator or Deputy Coordinator (if any), provided that limited, specific positions may be determined to be exempt from this requirement in consultation with legal counsel and consistent with governing law.

B. Reports to Law Enforcement.

- Reports of crimes may be filed with law enforcement with or without the assistance of the campus. Each campus will assist any student wishing to file a report to law enforcement.
- 2. The Title IX Coordinator or Deputy Coordinator, in consultation with appropriate campus officials, shall analyze each report of sexual violence to determine if a health or safety emergency as defined by state and federal law warrants disclosure of information relating to the complaint. In such case, information relating to the complaint will be disclosed to the appropriate persons including law enforcement personnel.
- Timely warnings or emergency notifications issued under the Clery Act related to sexual violence shall also be sent to local law enforcement agencies.

IV. Review and Approval of Procedures by the Office of General Counsel

All Title IX policies and procedures must be reviewed and approved by the Office of General Counsel prior to their implementation on each campus.

January 26, 2023 (Revised) May 22, 2014 BOARD POLICY 620.1

ADDITION, DELETION, SUSPENSION, REVIEW AND MODIFICATION OF ACADEMIC PROGRAMS

I. Purpose

The approval of the Board of Trustees is required for the addition, deletion, suspension, or significant modification¹ of academic programs.² The purpose of this policy is to provide guidelines for any such changes and for the ongoing review of existing academic programs.

II. Academic Program Reviews

Each campus³ shall be responsible for reviewing all established academic programs to evaluate whether any changes in the program are warranted. Two types of review shall be required for all established academic programs:

- (1) a review of the annual report of low productivity programs originating in the office of the chief academic officer of the campus, and
- (2) a periodic substantive evaluation of each academic program on a rotating schedule not to exceed 10 years.

Each campus shall establish guidelines and criteria to implement the substantive evaluation. Such guidelines and criteria shall be consistent with any applicable accreditation requirements, reviewed by the campus governance body⁴ and the chief academic officer, approved by the Chancellor, and furnished to the President. A recommendation for deletion, suspension, or significant expansion or modification of any program made as a result of either type of review shall be reviewed by the faculty of the program involved, the administrative head of the college, school, or other unit in which the program is located, the campus governance body, the chief academic officer, and the Chancellor. The Chancellor will forward his/her recommendations to the President who will report the results of the campus deliberation and make a recommendation to the Board for action.

¹A net change of more than fifteen credit hours in any twelve-month period.

²An academic program is a curriculum leading to a certificate, associate degree, baccalaureate degree, specialist degree, or graduate degree.

³ For purpose of this policy, the term "campus" includes not only any traditional "brick and mortar" campus but also any wholly online academic institution that is part of the System.

⁴ The review by a campus governance body is only required when an institution has a governance body and the review is required pursuant to the campus governance documents.

III. Addition of Programs

Guidelines for proposing new academic programs shall be developed by each campus and approved by the campus governance body, chief academic officer, and Chancellor and submitted to the President. Such guidelines must provide for review of proposed programs by the program or departmental faculty, college, school, or other sub-unit in which the program will be given, the campus governance body, the chief academic officer, and the Chancellor. If the Chancellor approves a proposal, it shall be forwarded to the President along with his/her own recommendations to the Board of Trustees for action. If the Board disapproves of the proposal, it shall be returned to the Chancellor for further action, if any, consistent with Board and campus policies and procedures.

IV. Board or President Initiated Program Deletions

The Board of Trustees reserves the authority to delete programs because of low demand, low productivity, a modification of the role and scope of the campus, or financial exigency (as defined in Board Policy 405.5), or upon the initiative of the President, regardless of a recommendation for such action by the campus. In all instances where the Board seeks to delete a program under this provision, the Board shall solicit comments and suggestions from the appropriate campus-wide governance body or bodies, from the Chancellor, and from the President before a decision is made.
